Definition: A **Lead Abatement Supervisor** has completed 32 hours of instruction on lead abatement. All lead abatement supervisors are required to perform abatement work under a licensed abatement contractor, have at least one year of work experience as a certified lead abatement worker, and at least one year of additional work experience in environmental remediation or the building trades. Any questions about licensing should call 603-271-4507.

A **Lead Abatement Worker** has completed 24 hours of instruction on lead abatement. All lead abatement workers shall not perform lead hazard reduction activities unless under the supervision of a lead abatement supervisor or contractor. Any questions about licensing should call 603-271-4507.
